# Instructions for supervised entities filling in NMC notification forms in the IMAS Portal

# 1. Introduction and general principles

This document provides instructions on how to fill in the ex post and ex ante non-material changes or extensions (NMC) notification forms in the IMAS Portal. The instructions first describe the simpler ex post form and then the more granular and risk type specific ex ante form. The annexes provide a list of validation rules and an explanation of how to create a new NMC process in the IMAS Portal.

The ex ante notification form is designed for notifying <u>one</u> single extension or change at a time. If you wish to notify several modifications,<sup>1</sup> please submit a separate form for each one. A modification may affect more than one risk type and more than one rating system or internal model. For this reason, the form allows several risk types, rating systems and models to be selected at the same time. For example, a change to a pricing function can have an impact on both the internal models approach (IMA) and the internal model method (IMM).

Depending on the risk type, the information requested is based on either Commission Delegated Regulation (EU) No 529/2014<sup>2</sup> as amended by Commission Delegated Regulation (EU) No 2015/942<sup>3</sup> (referred to in these instructions as "the CDR") or the <u>ECB Guide on materiality assessment</u> ("the EGMA").

All relevant documents must be uploaded in the form.

A pre-condition for using the form is that the institution submitting the notification and the institutions affected must have permission to use the internal model for which the modification is being notified.

Mandatory fields are marked with a red asterisk.

# 2. General overview of the ex post form

Modifications which are not material and do not need to be notified ex ante are notified after implementation (i.e. ex post) at least on an annual basis. Fill in the mandatory subject line with the time period to which this notification refers<sup>4</sup>, the risk type (e.g. "Credit Risk") and the models affected.

The form consists of three tabs: "General Information", "Documents" and "Declaration & signatures".

 1. General Information
 2. Documents
 3. Declaration & signatures

The "General Information" tab is used to collect general information such as:

- the name of the institution submitting the notification;
- the contact details of the person who can be contacted regarding the notification submitted;
- the time period for which the changes are being notified (either one quarter or one year);
- the risk type affected;
- a list of the models affected.

In the "Documents" tab, upload one or more files together with a list of the modifications you are notifying ex post. The uploaded files can be in any of the following formats: .doc, .docx, .pdf, .csv, .xls, .xlsx, .ppt and .pptx. The form includes a link to an Excel template which you can use. The list must include at least:

- a description of the modification;
- the date of internal approval;
- the date of implementation;
- the scope of application (including model or rating system ID);
- the entities affected;
- a list of relevant documents;
- the impact on risk-weighted assets, i.e. the "RWA impact" (if applicable).

The maximum file size for each document is 10MB.

If you notify internal ratings-based (IRB) model modifications and if the notification affects more than one rating system, you can (i) indicate directly in the IMAS Portal in the appropriate field ("How many rating systems does this ex post notification relate to?") how many rating systems you are notifying ex post modifications for and (ii) optionally include the rating system documentation in the notification. Please also add a column headed "Affected rating system" and enter for each ex post change the name of the rating system and the name of the related documentation in the file with a list of the modifications you are notifying ex post.

The "Declaration & signatures" tab has a link to a document with a declaration to read, sign and upload. The maximum file size is 3MB. The form accepts PDF, Word, PowerPoint and Excel files. Note that you need to include the name and role of the person signing the declaration.

Once all required fields are filled in, the form can be submitted. Please see Annex 4 for more details.

## 3. General overview of the ex ante form

Modifications which are not material and need to be notified ex ante are notified (depending on the risk type) two weeks or two months before implementation. Fill in the mandatory subject line with the risk type (e.g. "Credit Risk") and the model or rating system affected, unless you have received different guidance from your JST. Note that if the subject is empty, you cannot save the form as a draft. You can, however, save the form as a draft if other mandatory fields are empty.

The form consists of six tabs: a "General Information" tab, three risk type specific tabs ("Credit Risk", "Market Risk" and "Counterparty Credit Risk"), a "Documents" tab and a "Declaration & Signatures" tab. The form is used to collect qualitative and quantitative details on the modification.



#### 3.1 General Information tab

The first tab, "General Information", needs to be filled in for all risk types, and the entries determine which questions appear in the risk type-specific tabs. The content of this tab must be completed before proceeding to the other tabs. The different sections within the tab are described below.

## 3.1.1 Details of institution section

This section identifies the institution that is operationally submitting the notification ("the submitting institution"). This field is prefilled based on the account of the user submitting the notification and also depending on the "requesting institution" selected.<sup>5</sup>

The submitting institution can notify an NMC on its own behalf and/or on behalf of legal entities belonging to the same group. You can select these entities in the "Legal entities affected by the modification" field in order to notify the NMC on behalf of all these entities in the same form.

## 3.1.2 Details of risk section

In this section you can select the risk types which are affected by the modification notified. The selected risk types determine the information requested across all tabs. For modifications which affect multiple risk types, the form allows several risk types to be selected at once (e.g. where a change to a pricing function needs to be notified for both the IMA and IMM models or an organisational change affects multiple risks). The form does not check that the selected combination makes sense. The JST will contact you if your selection raises questions. If you submit an unusual combination, you can make the process more efficient by explaining the reason for this in the "Description of the modification" field (see below).

The "Model name" field is a dropdown that contains all models for which the group has received permission.<sup>6</sup> From this list, select all models affected by the modification. To make it easier to identify the models desired, the form includes a button below the dropdown called "Export all models as CSV". Clicking this allows you to download a csv file with the list of all models available for selection. In case the models desired cannot be found, please contact your respective JST.

#### 3.1.3 Details of change section

This section collects information on the type of modification. It is split into three parts: "RWA impact", "Modification" and "Supervisory measures".

#### 3.1.3.1. RWA impact

The first question asks whether the modification has an **impact on RWA**. If you select yes, you need to provide more details on the group structure.<sup>7</sup> This selection influences which quantitative impact figures are required in the risk type-specific tab; see the sections below on the specific risk types for more details.

Note that for the IRB approach and IMA, the CDR requires quantitative impacts to be calculated at the consolidated level of the EU parent institution in cases where an EU parent institution exists (the notifying institution itself can also be the EU parent institution; in this case it needs to be listed as a legal entity affected by the modification).<sup>8</sup>

While the EGMA does not make explicit reference to an EU parent institution, its intention, in the same manner as the CDR, is to require quantitative impacts to be submitted. The form therefore requires the submission of the overall counterparty credit risk (CCR) RWA at the consolidated level of the EU parent institution.

Generally, the case where an institution is neither an EU parent institution nor a subsidiary of an EU parent institution applies only to groups which consist of only one legal entity.<sup>9</sup> If there is more than one legal entity within the EU, there is normally an EU parent institution. In the event that the submitting institution is a subsidiary of a non-EU parent,<sup>10</sup> this form should only reflect those modifications which affect the group's legal entities within the EU.

As the notifications for different legal entities are formally separate, even if submitted in the same form, banks can use different reference time periods for the calculation of quantitative impacts for different legal entities. In this case, the form requires quantitative impacts to be submitted at EU parent institution level for each reference time period.

However, it is more common for banks to use the same reference time period across all legal entities when calculating quantitative impacts. To cater for this, the Market risk and Counterparty credit risk tabs all have a check box to indicate that the reference time period is the same across all legal entities. When

you tick this box, you only need to enter the reference time period and the quantitative impacts at EU parent level once.

If you select no RWA impact, the legal entities affected by the modification only need to be entered in the "General Information" tab and no details on the group structure are required. Please provide a brief explanation of why the modification notified does not have any RWA impact. Changes with no RWA impact include structural, organisational and operational changes.

## 3.1.3.2. Modification

In this sub-block you can select the **type of modification**. For market risk and counterparty credit risk, the model change(s) and model extension(s) options are available. For credit risk, an additional option is available, namely "*Notification driven by changes (not described in Annex I, Part I, Section 2 and/or Annex I, Part II, Section 2, CDR) which result in a decrease of at least 5% of the CRWA associated with the range of application of the internal rating system or internal models approach to equity exposures, in accordance with Article 5(1)(a)(iii) of the CDR".<sup>11</sup> This third modification type<sup>12</sup> can only be notified by itself (the change or extension option cannot be selected at the same time). In addition, it always requires quantitative impact figures.* 

A modification cannot normally be both a model change and a model extension. If you tick both boxes, please explain in the "Description of the modification" field why the same modification is at the same time both a model change and an extension.

In the "Description of the modification" field, please provide a brief description of the modification, including its rationale and objective as requested in Article 8(1) of the CDR and Sections 8(1)(a) and 8(2)(a) of the EGMA. If there are any unusual aspects to the modification or the notification, explain this here to minimise the need for additional information requests from the JST.

If applicable, also enter the reference to the internal model change policy (MCP).

#### 3.1.3.3. Supervisory measures

If the modification is linked to any supervisory measures and if its purpose is to remove these measures, please select all relevant types of supervisory measures and include a reference to any documents (e.g. decision on internal models) and the precise reference numbers of the measures (e.g. number of obligation and deadline) as reported in the relevant decision.

Please note that if a modification is related to a limitation, you need to reflect this in the quantitative impacts you provide – please see the risk type-specific sections below. In this case, too, the reference to the corresponding obligation(s) is mandatory.

By contrast, if a modification is related to an obligation but not to any limitations, this is not reflected in the quantitative impacts. However, such obligations still need to be listed here.

## 3.2 Credit Risk tab

#### 3.2.1 Quantitative information

If you indicate in the "General Information" tab that the modification has no RWA impact, this subsection is empty, and you do not need to enter anything.

If you indicate in the "General information" tab that there is an RWA impact, this subsection must be filled in. The form requests all figures needed to compute quantitative impacts in accordance with Article 4(2) of the CDR. Only absolute amounts of RWA (in euro) are requested and then the form automatically computes the relative impacts. If your reporting currency is not euro, please consult your JST. In addition, the IMAS Portal directly checks if the impacts are below the materiality thresholds defined by the CDR; if one of the impacts exceeds the threshold described in Article 4(1)(c) of the CDR, the modification is material and requires permission from the ECB.

Please enter the point in time of the impact calculation (reference date for the computation coming from the model change) and details of the impact estimation if a representative sample of the portfolio has been used for the impact computation.<sup>13</sup> According to paragraph 108(a) of the ECB guide to internal models, the time between the reference date and the date of the notification should not exceed nine months. If more than nine months have elapsed since the reference date, please provide an explanation in the dedicated text box.

In this tab, impact figures are requested at the level of the EU parent institution or at the level of the institution that is neither a parent nor a subsidiary, in accordance with Article 4(1)(c)(i) of the CDR. Further information at rating system level will be requested in the "Rating system" tab<sup>14</sup> (please refer to Section 3.2.2).

Besides the RWA impacts, other quantitative figures before and after the change are requested, namely the Tier 1 capital ratio, Common Equity Tier 1 (CET1) capital ratio and the expected loss. In addition, at rating system level, the exposure at default (EAD) amount before and after the change is requested. It is worth highlighting that, in accordance with Article 4(2) and Article 4(3) of the CDR, when computing the RWA impact of the change the set of exposure is assumed to remain stable (the exposure pre-conversion factor needs to remain stable before and after the change). This should be considered for all changes, including those related to the scope of application,

#### 3.2.1.1. Treatment of limitations in quantitative impact calculations

If the models or rating systems affected by the modification are subject to a limitation, this needs to be reflected in the quantitative impact calculation as described below, depending on the type of limitation.

If the modification has the purpose of removing a limitation by fully addressing all obligations underlying this limitation, quantitative impacts should be calculated as set out below. Note that the obligations in question should be specified in the "Supervisory measures" field in the "General Information" tab.

- All figures before the modification should include the impact of the limitation.
- All figures after the modification should not include the impact of the limitation.

The impact calculation should assume that the limitation is removed as a result of the modification.

This approach applies to all types of limitations: multiplier, add-on and floor at the level of risk parameters or at RWA level.

Please note that while the impact calculation implicitly assumes the removal of the limitation, this does not imply that the institution will automatically be allowed to lift the limitation. The JST will assess the change and inform the institution whether all related obligations are assessed as fulfilled and thus whether the limitation can be removed.

By contrast, if the model being modified is subject to a limitation but the modification is not directly related to the limitation, the limitation needs to be included in all figures both before and after the modification.

#### 3.2.2 Rating system

The quantitative impact for each rating system affected by the change or extension must be entered via "Add rating system". The name of the rating system has to be entered; no dropdown is available. Next, the related quantitative information at rating system level must be entered. Once all the figures have been inserted, the tab should be saved and closed. If the model change affects more than one rating system, this step must be repeated for each of them. This will allow the RWA impacts to be computed in line with Article 4(1)(c)(ii) of the CDR.

It should be noted in this context that validation rules relating to the thresholds set out in Article 4(1)(c)(i) and (ii) of the CDR are included.<sup>15</sup> This means that if the RWA impacts do not meet the quantitative criteria for the modification to be classified as non-material with ex ante notification, the NMC cannot be submitted through this form.

If the model modification falls under Article 5(1)(a)(iii) of the CDR, the validation rule includes the 5% threshold at rating system level, instead of the 15% threshold.

Once all the figures have been entered, this tab shows a summary of the RWA impacts in line with Article 4(1)(c) of the CDR.

Finally, it should be noted that if the modification has no RWA impact, the name of the rating system(s) level affected still needs to be entered.

## 3.2.3 Model change/extension

The content of this section depends on the entries in the "Modification" subsection of the "Details of change" tab.

Exposure class(es) and credit risk parameter(s)<sup>16</sup> need to be entered first of all. It should be noted that information on exposure class(es) is necessary to allow the form to display all the possibilities in the subsequent tab.

Depending on whether "Model extension" and/or "Model change" is selected in the "General Information" tab, one of the two different sections will appear: "Changes to the range of application of rating systems or an internal models approach to equity exposures" or "Changes to rating systems or internal models approaches to equity exposures". This part of the form allows the bank to select the relevant paragraph(s) of the CDR explaining the modification submitted through the NMC process. In particular, it has been designed in an interactive way: first, the area that the notification concerns needs to be selected (e.g. reduction in the range of application, changes in the rating methodology for IRB systems, validation); second, the relevant paragraphs of the CDR, i.e. those related to the area in question, need to be selected.

Note that all the areas and paragraphs are prefilled with the answer "No", so only those relevant to the NMC notification need to be switched to "Yes". In addition, a text box will appear in which to insert the detailed reference indicating where to find information in the attached documentation. If it is possible for

the change to be assessed either as material or non-material, the bank should provide further information on where a detailed description of the assessment and conclusions can be found in the documentation provided.

Finally, note that if "Notification driven by changes (not described in Annex I, Part I, Section 2 and/or Annex I, Part II, Section 2, of the CDR) which result in a decrease of at least 5% of the CRWA associated with the range of application of the internal rating system or internal models approach to equity exposures, in accordance with Article 5(1)(a)(iii) of the CDR" is selected in the "General Information" tab, the bank should only provide information on exposure class(es) and credit risk parameters affected by the change.

## 3.3 Market Risk tab

#### 3.3.1 Risk categories

Please select which of the risk categories listed in Article 363(1) of the CRR for which the legal entity has formal approval are affected by the modification. If the change affects the incremental default and migration risk charge (IRC), please select "d) specific risk of debt instruments".

## 3.3.2 Quantitative information

If you indicate in the "General Information" tab that the modification has no RWA impact, this subsection is empty, and you do not need to enter anything.

If you indicate in the "General Information" tab that there is an RWA impact, this subsection must be filled in. The form requests all numbers needed to compute quantitative impacts in accordance with Article 7a(1)(c) of the CDR. It checks that the impacts are below the materiality thresholds defined by the CDR; if one of the impacts exceeds the threshold, the model modification is material and requires permission from the ECB.

The time period for market risk is one day or 15 consecutive business days. Under the CDR, if on the first day of the impact calculation all risk numbers change by less than 1%, then no additional impact calculations are needed. The form therefore allows a reference time period of one day to be entered. When the reference time period is only one day, the quantitative impact fields at EU parent level are voluntary. The impacts on individual risk numbers are still mandatory for all legal entities, and they must be less than 1%.

The form does not allow reference time periods between two and 14 business days. A time period between two and 14 days implies that one of the materiality thresholds in CDR has been exceeded. In this case, the modification is material and cannot be notified as an NMC. The form allows longer

reference time periods and requests a free text form explanation when this is the case. Longer time periods could, for example, be the result of local public holidays, which the form does not take into account.

#### 3.3.2.1. Group structure

1) If there is an EU parent institution or the notifying legal entity is the EU parent:

Within a group the approval for the risk categories and consequently the risk categories affected by the modification may vary. The form allows you to indicate whether the risk categories affected are the same across all legal entities.

As the notifications for different legal entities are formally separate, even if submitted in the same form, banks can use different reference time periods for the calculation of quantitative impacts at the EU parent institution level for different legal entities, and the form requires quantitative impacts to be submitted at EU parent institution level for each reference time period. However, it is more common for banks to use the same reference time period across all legal entities when calculating quantitative impacts. If you indicate that the reference time period is the same across all legal entities, the form will request the impact figures at the EU parent institution level only once.

If you select "Time period and EU parent institution level impacts are the same across all entities affected by the modification", the form requests the start and end dates of the reference time period and the impact figures at the EU parent level only once. To enter the impact figures for the affected risk numbers (VaR, SVaR, IRC and/or CRM)<sup>17</sup> for a legal entity affected by the modification, please use "Add legal entity".<sup>18</sup>

If the time period and EU parent institution level impacts are not the same across all entities affected by the modification, the form will request the reference time period and the impacts at EU parent level for each legal entity affected, together with the consolidation level, next to the risk figures in the "Affected entity" window. The form will request impact figures for the affected risk numbers (VaR, SVaR, IRC and/or CRM) for the selected reference time period at legal entity level as well.

If you select "The affected risk categories are the same across all legal entities", the form requests the list of affected risk categories only once. Otherwise, you need to enter the list of affected risk categories for each affected legal entity.

2) If the institution is neither an EU parent institution nor a subsidiary of an EU parent institution:

This option is intended for cases where there is only one legal entity within the EU. (Parents outside the EU do not count as EU parent institutions.) The form will therefore only ask for figures at the level of that one entity.

## 3.3.2.2. Treatment of limitations in quantitative impact calculations

If the IMA permission is subject to a limitation, this needs to be reflected in the quantitative impact calculation as described below, depending on the type of limitations.

If the modification has the purpose of removing a limitation, by fully fulfilling all obligations underlying this limitation, quantitative impacts should be calculated as set out below. Note that the obligations in question should be specified in the "Supervisory measures" field of the "General Information" tab.

Here, the term "risk figures" means the individual risk numbers listed in Article 7a(1)(c)(ii) of the CDR. The term "risk figure sum" means the sum as defined in Article 7a(1)(c)(i) of the CDR.

The figures after the modification should not include the limitation. The only exceptions are limitations that change the increase to the multiplication factors, which should be included in the figures after the modification as well as the figures before the modification. The figures before and after the modification should be calculated using the multiplication factor from COREP.

The figures before the modification should incorporate the limitation in accordance with the following:

- 1. In the case of a limitation that sets an add-on for a specific risk measure, add the add-on to the risk figure sum, and include in the relevant risk figure as follows:
  - a. Relative add-ons can be directly applied to the relevant risk figure.
  - b. Absolute add-ons to 10-day VaR or sVaR are divided by the relevant multiplication factor and applied to the relevant risk figure.
  - c. Absolute add-ons to IRC or CRM are added to the relevant risk figure.
- 2. In the case of a limitation that sets an add-on to overall own funds requirements (OFR) or RWA for market risk, include it in the risk figures as follows:
  - a. Relative add-ons can be directly applied to all risk figures.
  - b. If the obligation(s) linked to the limitation apply only to one risk figure, attribute the add-on to the relevant risk figure. (In the case of VaR or sVaR, divide the add-on by the relevant multiplication factor.)
  - c. If an absolute add-on relates to several risk figures, attribute it pro rata to each relevant risk figure, according to the contribution of each risk figure to the risk figure sum. In the

case of VaR and sVaR, the contribution includes the multiplication factor. To add the prorata share of an absolute add-on to 10-day VaR or sVaR, divide it by the relevant multiplication factor.

- d. If an absolute add-on cannot be assigned to specific risk figures, attribute it pro-rata to all risk figures following the same principles as in c above.
- 3. If you want to notify a modification that does not fall under any of the above categories, approach your JST ahead of time to discuss how best to reflect it.

The following two examples illustrate the allocation of limitations to risk figures. Example 1 assumes an add-on of €10 million on OFR for market risk. Example 2 assumes an add-on of €10 million on IRC or on OFR related to IRC. Both examples assume VaR and sVaR multipliers of 3.

Please note that while the impact calculation implicitly assumes the removal of the limitation in such cases, this does not imply that the institution will automatically be allowed to lift the limitation after implementation of the modification. The JST will assess the change and inform the institution whether it assesses the obligations have been fulfilled and thus whether the limitation can be removed.

By contrast, if the model being modified is subject to a limitation but the modification is not directly related to the limitation, the limitation needs to be included in all figures both before and after the modification.

#### 3.3.3 Model extension

If you indicate in the "General Information" tab that the modification is not a model extension, this subsection is empty, and you do not need to enter anything.

Select the qualitative criteria for the classification of NMC that apply to the extension you are notifying according to Annex III Part I Section 2 of the CDR. If you select "other", describe which other risk modelling techniques you plan to include in the scope of the IMA model. The form allows all criteria to be selected at the same time. Nevertheless, only one extension should be notified at a time.

#### 3.3.4 Model change

If you indicate in the "General Information" tab that the modification is not a model change, this subsection is empty, and you do not need to enter anything.

Select the qualitative criteria for the classification of NMC that apply to the change you are notifying. All categories of Annex III Part II Section 2 of the CDR are listed in this subsection. To select a category, change the prefilled "No" to "Yes". The form allows all criteria to be selected at the same time. Nevertheless, only one change should be notified at a time.

#### 3.4 Counterparty Credit Risk tab

#### 3.4.1 CCR Risk category

Please select which of the CCR categories are affected by the change/extension; "other risks" may also be selected.

#### 3.4.2 Quantitative information

If you indicate in the "General Information" tab that the modification has no RWA impact, this subsection is empty and you do not need to enter anything.

If you indicate in the "General Information" tab that there is an RWA impact, this subsection must be filled in.

Please refer to the IMA section regarding the tick boxes "The affected risk categories are the same across all legal entities" and "Time period and EU parent institution level impacts are the same across all entities affected by the modification"; see Section 3.3.2.

The form requests all numbers needed to compute quantitative impacts in accordance with Section 4(1)(c) of the EGMA. It checks that the impacts are below the materiality thresholds defined by EGMA; if one of the impacts exceeds the threshold, the model change needs to be investigated by the ECB.

## 3.4.2.1. Treatment of limitations in quantitative impact calculations

If the model is subject to a limitation, please follow the same approach as for IRB models; see Section 3.2.1.1. This approach also applies to alpha increases via limitation.

#### 3.4.3 Model extension

If you indicate in the "General Information" tab that the modification is not a model extension, this subsection is empty, and you do not need to enter anything.

The EGMA does not list criteria for extensions which need to be notified ex ante. Therefore please only provide an explanation of why none of the criteria listed in Annex I, Part I, Section 1 of the EGMA is applicable.

## 3.4.4 Model change

If you indicate in the "General information" tab that the modification is not a model change, this subsection is empty and you do not need to enter anything.

Select the qualitative criteria for the classification of NMC that apply to the change you are notifying. All categories of Annex I Part II Section 2 of the EGMA are listed in this subsection. To select a category, change the prefilled "No" to "Yes". The form allows all criteria to be selected at the same time. Nevertheless, only one change should be notified at a time.

#### 3.5 Documents tab

Upload the relevant documents in accordance with whichever of the following applies:

- Article 8(2) of the CDR
- Section 8 of the EGMA

The maximum file size is 10MB. The form accepts the following formats: .doc, .docx, application/msword, .pdf, .csv, .xls, .xlsx, application/vnd.ms-excel. PDF is preferable for documents where possible.

## 3.6 Declaration & Signatures tab

This section confirms that the modification notified is not a material one and has received the appropriate internal approval.

Enter the date of approval as referred to in Article 8(1)(f) of the CDR or Section 8(1)(f) and 8(2)(a) of the EGMA. The date of approval cannot be after the date of the notification via the IMAS Portal.

Enter the (planned) implementation date as referred to in Article 8(1)(b) of the CDR or Section 8(1)(b) and 8(2)(a) of the EGMA. The minimum time between notification and (planned) implementation depends on the risk type.

Upload the signed declaration. The maximum file size is 3MB. Please upload it as a PDF.

The form can be submitted once all required fields have been filled in. Please see Annex 4 for more details.

# 4. Processes and messages in the IMAS Portal

The notifications are created as messages and listed in the "My Processes" tab in the portal with the status "Draft", "Notified", "Completed" or "Cancelled". The status should be understood as follows:

- "Draft" means that you have not yet submitted the notification to the ECB. You can still change the form and your JST cannot see it yet.
- "Notified" means that you have submitted the notification to the ECB. You can no longer change the form and the JST can see it.
- "Completed" means that your JST has marked the corresponding internal task as complete. You will receive an automated message confirming when a process changes to "Completed". This does not reflect the assessment of the notification by the JST.
- "Cancelled" means that the notification is discarded. Cancelled messages are shown alongside completed ones in the dashboard.

In the "All Messages" tab, the message types "NMC ex-post notification initial submission" and "NMC exante notification initial submission" can have the status "Draft" and "Notified". The message type "Process status update" has the status "Received".

The message type "Request for Information" serves as a channel for communication with the JST. It will be used by the JST to ask for additional details on the documentation, for instance where a relevant attachment is missing from the notification or some of the information included in the form is not adequate. You can reply to each "Request for Information" message only once by selecting the required option:

- "Information" message to exchange text with supervisors and attach information to your answer.
- "Update existing" to update the submitted information in the form. Select the last submission (first in the list) if you need to amend, delete or add data.

The status of the message will be "Received", the status of your reply will be "Pending Confirmation" first and then "Notified".

You can also receive messages of the type "Information", which are one-way messages. There is no option to reply to such messages. There is however the option of creating a new separate information message to the JST, also linked to the same notification.

Please contact your JST if, exceptionally, you need to withdraw the notification and no longer plan to implement the modification (see Article 3(7) of the CDR). The JST can delete the notification and its status will then change to "Cancelled".

Please see Annex 5 for further details.
